#### 1. PHILOSOPHY

- VII. We will consult with our employees on health and safety matters.



- VIII. Our objective is a safety and health program that will reduce the number of injuries and illnesses to an absolute minimum, not merely in keeping with, but surpassing, the best experience of operations like ours. Our goal is nothing less than zero accidents and injuries.
- IX. We will conduct our operations in the spirit of applicable environmental rules & legislation regarding Carbon Emissions, waste (hazardous & non-hazardous) generation, management, and disposal.
- X. We commit to investing in resources that improve the environmental aspects of our processes
- XI. We will build environmental awareness among employees and business partners by encouraging them to work in an environmentally responsible manner through appropriate training
- XII. We will maintain regular communication with the CSR & Sustainability Committee on sustainability matters of the company
